INTRODUCTION

These regulations apply to the delivery of goods to MEINHART KABEL Österreich GmbH in A-4490 St. Florian/AUSTRIA or on their behalf to the specified delivery address.

These regulations essentially describe the requirements for packing, transport, labeling and documents.

The General Terms and Conditions of Purchase of MEINHART Kabel Österreich GmbH also form the basis for every ordering process, provided no other contractual agreements have been made with the contractual partner (www.meinhart.at/service/download).

We would like to point out that this regulations cover the minimum requirements only and do not claim to completeness.

1. PACKING

The quality of packing must be done in a way that:

- a. goods are protected from damages during transport
- b. packaging is prepared to the weigt of the goods
- c. unloading with a fortklift is possible without risk

1.1. PALLETS

Cables and wires on pallets will be stored in rack systems.

Fast moving items are sometimes stored under the roof with up to 4 palltes stacked on top of each other.










1.1.1. CONDITION OF PALLETS

For transport on palltes, EURO pallets must be used in accordance with below mentioned dimensions. The use of other pallets is permitted as long as dimensions listed as well as stability of the pallets for shelf storage (maximum 1000 kg) of the delivered goods is guaranteed.

Dimensions of pallets:

width: 80 cm
 length: 120 cm
 height: 14,4 cm
 load capacity: at least 1000 kg





The goods may not overtop more than 50mm in length and 50mm in width of the pallet:

max. 2,5 cm



Maximum height of a loaded pallet including pallet: 112 cm !

Remark:

The maximum total weight applies to both EURO pallets and non-returnable pallets. The load capacity of the pallets must be at least 1000 kg.



1.1.2. LOADING THE PALLETS

The goods (coils, boxes, drums etc.) should be loaded in such a way that the surface of the pallet is covered as much as possible and slippig during transport is not possible. Coils and drums must be fixed on the pallet in such a way that prescribed dimensions in item 1.1.1. do not exceed.



The surface of the loaded pallets must be flat to make storage as described in item 1.1. possible. This applies to full pallets only!

Different cables types, cross sections or packing units may never be packed together on one pallet.

- a. only one item per pallet
- b. only one packing unit per pallet.

Example: coil 50m and coil 100m may not be packed together on one pallet

quantities. Appropriate demand provided.

c. the pallet quantity and packing unit for each single product must be coordinated with our purchase department in order to adjust the order quantity to full pallet

The specified pallet quantity must be the same for each delivery (see item 1.1.). This also applies to the drum sizes.

Example:

500m J-Y(ST)Y 2x2x0,8 delivery always in the same drum size and quantity per pallet.

d. Exceptions:

Remaining length of different products can be packed together on one pallet. Each remaining length must be marked in color.

1.1.3. PACKING OF PALLETS FOR TRANSPORT

Each packed pallet must be protected with stretch foil to prevent slipping during transport.

It is important that the stretch foil is also wrapped around the pallet frame in order to create a compact and stable packing unit.

The stretch foil must not stick to the foil of coil and drums.

Only **transparent** stretch foils are accepted.

This applies to coils as well as to plywood drums, boxes or spools.

Multiple pallets may not be wrapped together!

1.1.4. MARKING OF PACKED PALLETS

Both narrow sides of the pallet must be marked with a label. The label can be fixed on the outside or inside of the stretch foil.





Below informations must be listed on the label at least:

- manufacturer
- recipient (usually the buyer)
- GTIN (formerly EAN number)

1.2. COILS

Coils may only be delivered wrapped in foil or carton box.

The core diameter must be adapted to the bending radius of the cable/wire.

Winding must be done "layer by layer".

1.2.1. MARKING OF COILS

Each single coil must be marked with a label. The label must be placed under the foil or on the foil. Below informations must be listed on the label at least:

- name of product
- cross section
- color (RAL color code if specified on the purchase order)
- GTIN (formerly EAN number)
- quantity in meter
- standard (VDE, HAR, IEC)
- CE marking for those products that are under EU directive 2006/95/EG

1.2.2. COILS ON PALLETS

It is recommended to place a layer of cardboard on the pallet that covers the total dimension of the pallet $(80 \times 120 \text{ cm})$.

The coils should be stacked close together that pallet is as stable as possible.

Below dimensions may not be exceeded:

The coils/boxes are secured on the pallet using straps, stretch foils or shrink foils. Stability of pallets must also be guaranteed in case of unforseen situations during transport (e.g. emergency break of the truck).

1.3. DRUMS

We differentiate between PLYWOOD DRUMS and WOODEN DRUMS.

Cables on plastic drums, iron drums or KTG drums may only be delivered with prior written approval from our purchase department.

Cable drums are stored on pallets (plywood drums) in the high rack warehouse as well as outdoor (wooden drums).

Quality, size, stability and load capacity of the drums must be adapted to the weight as well as to the allowed bendig radius of the cables/wires.

1.3.1. PLYWOOD DRUMS

Plywood drums may only be deliverd horizontal (laying on the flange) on pallets and flange diameter may not exceed 800 mm.



Winding of the drums must be done in a way that a safety distance of at least 30 mm is ensured between the outer layer of the cable and the edge of the drum flange.



Stability of the flange must be suitable for transport as below:





1.3.2. WOODEN DRUMS

- a. drums must be weather resistant and load capacity may not be impacted by long term storage outdoor.
- b. damaged flanges or brittle wood will not be accepted.
- c. load capacity of the drum must be in accordance to the weight of a full drum.
- d. wooden drums must be in accordance with the IPPC standard ISPM no. 15
- e. to avoid any mold on drums, only dry wood should be used.





f. Winding of the drums must be carried out in accordance with the VDE 0298 standard in a way that a safety distance of 1,5 x D to 2 x D (D = outer diameter of the cable) but at least 80 mm is ensured between the outer layer of the cable and the edge of the drum flange.





g. Winding of drums must be done "layer on layer" and may not be spooled too loosely.





 drums with a flange diameter of up to 800 mm need to have a safety distance of at least 30 mm.



 stability of the flange (up to maximum 140 cm flange diameter) must be suitable for below transport according to sketch:



- j. cables where the outer jacket is not colored black must be protected with UV resistant foil including the drum flange.
 - The foil may not be fixed to the cable with adhesive tape.
 - To ensure that the foil remain on the drum even in case of strong wind, we recommend to fix the foil with adhensive tape on the outside with several times over an entire turn.
- only one cable length may be spooled per drum.
 Partial length must always be spooled on separate drums without any exception (risk of injury).
- I. Winding of drums must be done "layer on layer".

- m. Full casing of wooden drums is only permitted upon request in accordance with our purchase order or after consulting with the purchase department.
- n. The cable ends must be sealed or welded watertight with PVC plug caps or shrink caps.
- o. Cable end must be fastened properly that end caps will not be damaged during transport.

Nails are not permitted to fix the cable end!

p. Due to vibrations during transport, cable ends with a cable outer diameter > 25mm should be preferably fixed at the flange with a textile cord.









1.3.3. MARKING OF DRUMS

A weather proof label must be fixed at the outside and inside of the drum flange.

Below informations must be listed on the label at least:

- name of product
- cross section
- color (RAL color code if specified on the purchase order)
- GTIN (formerly EAN number)
- quantity in meter
- standard (VDE, HAR, IEC)
- CE marking for those products that are under EU directive 2006/95/EG
- weight (cross weight and net weight)
- drum number must be the same drum number as listed on the delivery note
- CPR marking for those products only which are under the CPR regulation (Construction Products Regulation) and declared as such in the purchase order including
 - name of the manufacturer
 - CPR classification (Eca, B2ca etc...)
 - DoP number

1.3.4. DRUMS ON PALLETS

- a. Drums with a flange diameter of up to 800 mm which will be shipped on pallets must be fixed horizontal (laying on the flange) on the pallet.
- b. Loading the drums vertically (standing) on pallets is only permitted after coordination and written approval from our purchase department.
- c. The position of the drums on the pallet must be in a way that the drums are within the external dimensions (80 x 120cm) of the pallet and the cables will not be damaged by the drum flange.










PLYWOOD DRUM SIZE 045



1.4. TOLERANCES

- a. Over-delivery as well as under-delivery of the stated quantity in the purchase order of up to +/- 5% for each position is permitted, if no partial length with agreed length tolerances were specified in the purchase order.
- b. Following length tolerances apply to the individual packing units:

• Standard length of coils (e.g. 25, 50, 100m): +/- 0%

• Standard length of drums (e.g. 300, 500, 1000m etc.): +/- 0%

• Maximum length of drums: +/- 10%

- Non standard length on drums effected by the production process may only be delivered after prior written approval from our purchase department.
 No special length are accepted for coils.
- d. Non standard length must be packed on extra pallets!
- e. Drums with non standard length must be marked color.





2. TRANSPORT

- a. Goods may only be delivered using tarpaulin trucks and tarpaulin trailers. Unloading must be possible from both sides of the truck and trailer and will be carried out by forklift.
- b. Containers are only permitted for the delivery of goods on pallets.
 Consider requirements described in item 1.1
- c. Wooden drums up to size 141 (140 cm flange diameter) can be loaded horizontally (laying on flange) on the truck.

d. Wooden drums size 161 and up (160 cm flange diameter) must be loaded vertically (standing) with the flange parallel to the side wall.



Loading across the direction of travel is possible, but weight of drum may not exceed 7000 kg and a safety distance of >= 20 cm must be provided between the drum flanges for unloading by forklift:



e. It must be ensured that the tarpaulin guide rails on the truck can be opened.

The truck driver must move the rails for safe unloading.

f. Transportation lock:

The goods must be secured using suitable components such as tension straps, wooden beams, wooden frames etc. that damages, slipping or overturn are excluded during transport, even in case of emergency break by the truck driver.

g. Driving nails into the drums or pallets is not permitted.





- h. Plywood drums that are fixed with straps should be protected from damge by using edge protection.
- Pallets with coils may only be transported stacked if the lower pallet has a flat surface and is protected from damage by a cardboard or wooden plate.
 Both pallets must be appropriately secured against slipping or falling.
 Note: heavy pallet below, light pallet on top
- j. Stacked pallets may not be wrapped in foil together or even nailed together.
- k. Pallets with plywood drums may be transported stacked.
- I. Pallets with wooden drums may NOT be transported stacked.
- m. Wooden beams or cardboard between drums are not permitted.

2.1. DELIVERY

- a. Delivery to the central warehouse in A-4490 St.Florian/AUSTRIA is currently carried out without a time slot during opening times listed.
 - Time slot booking for 2024 is in process and will be announced in time.
- b. We keep the right to refuse trucks if the packing regulations described in chapter 1 have not been taken into acount.
- c. Products and packing units where multiples of a truck quantity has been ordered, "pure" trucks must be delivered. That means, there is only one product in the same packing unit on the truck.

d. Change of EURO pallets

If EURO pallets are delivered, they will be replaced /exchanged with the same number of empty EURO pallets after unloading.

If the truck driver / forwarder do not want to load empty EURO pallets, the "pallet account" will be set to zero. Any exchange at a later date is no longer possible.

2.2. **NOTIFICATION OF A DELIVERY**

- a. As soon as the goods/truck leaves the factory delivery notification (aviso) must be sent by email to: avisos@meinhart.at
- b. The notification includes a copy of the delivery note or packing list and must contain the exact content of the transport.
- If there are discrepancies between the delivery note/packing list and the content of the transport/truck, we keep the right to charge 150 EUR per transport/truck. Acceptance of the goods will be refused and uloading will only take place when all necessary documents have been correctly submitted and unloading is possible.
- d. Acceptance of goods is only possible at listed open hours:

Monday to Thursday: 07:00 a.m. - 12:00 p.m. and 12:30 p.m. - 15:00 p.m.

e. The truck must leave our premises immediately after unlaoding. Parking or waiting for the next transport order on our yard is strictly forbidden! The use of parking areas outside the company premises for trucks that have already been unloaded is forbidden too!

3. DOCUMENTS

The delivery documents describe the entire delivery process and enable complete tracing of each individual packing unit from loading at the manufacturers plant to unloading at MEINHART warehouse or specified destination address including payment process of the delivered goods. Every delivery requires a prior written order from MEINHART KABEL Österreich GmbH.

3.1. PURCHASE ORDER

- a. Orders will be sent to the supplier exclusively by our purchase department by email.
- b. Our General Terms and Conditions of Purchase in the currently valid version (www.meinhart.at/service/download) are the basis for every order.
- c. The delivered goods must be ROHS/REACH conform. If this cannot be confirmed by the manufacturer/supplier, a written approval from our purchase department is required before order acceptance and delivery.

3.2. ORDER CONFIRMATION

- a. The order confirmation has to be sent to the contact person listed in the order header within 5 working days after receiving the order.
- b. A copy of our order confirmed in writing by the supplier also counts as an order confirmation.
- c. Below informations must be listed on the order confirmation:
 - manufacturer/seller
 - number and date of order confirmation
 - contact person of the manufacturer, name and email
 - number and position of Meinhart order
 - Cable type including cross section, color, voltage range, standard,
 - Quantity, packing unit,
 - Base price and metal factor according to Meinhart order
 - Metal base (ALL IN or HOLLOW or 150 or 100 etc.)
 - Metal quotation and metal adjustment according to the order (LME, day of order, monthly average, etc.)
 - Payment terms as per order
 - Delivery date and delivery address (arrival date at the specified delivery address)
 - Incoterms as per order
 - Special agreement if stated on the order
